If you choose to designate your gift to a specific agency, it must have an IRS tax exempt 501(c)(3) status and meet all regulatory and compliance standards required by law. The agency must provide direct health and/or human services, benefits, or assistance and be nondiscriminatory in service delivery. Agencies that are organized primarily for political, fraternal, fundraising, educational, religious or cultural purposes are not eligible.

All designated gifts must be \$100 or more.

If your selected organization does not qualify or your gift is less than \$100, your designation will default to the Community Fund.

A 12.32% administrative processing fee will be deducted from payments made to designated agencies.
