## **Reproduction Policies and Fee Schedule**

### **Earl H. and Anita F. Hess Archives and Special Collections**

Elizabethtown College is committed to making research materials available to users on equal terms of access in accordance with the professional policies on access adopted by the library and archival communities. We may assess fees to recover the costs of producing reproductions.

### **Patron Photography for Personal Research Use**

Researchers may use a cell phone or a small camera to photograph collection items for personal research use only. Portable scanners and flash photography are prohibited. If additional images of materials are required, photocopies or scans will be produced by the Archivist or a Library staff member on duty and fees may apply (see below).

### **Publication and Exhibition**

Publication or exhibition of materials from the Hess Archives and Special Collections in any media requires completion of a Permissions Request Form (Non-Exclusive License Agreement).

### **Reproduction Requests**

The Archives may refuse to make copies of materials that may be harmed in the process. Researchers are to use provided bookmarks along with a Reproduction Order Form, including a written list of items to be copied to indicate which items they would like to be reproduced. Every effort is made to provide reproductions in a timely manner, and requestors can expect a turnaround of 5 – 10 business days for digital delivery. Please consult the Archivist for information on available digital formats.

### **Elizabethtown College Community Requests**

Elizabethtown College students, faculty, and staff are not charged for reproduction of materials in the Hess Archives and Special Collections that can be reproduced in-house by Library staff. Students requesting more than 20 reproductions per semester will incur a per reproduction fee of \$2.50 per scan or at the discretion of the Archivist.

## **External Requests**

The Hess Archives and Special Collections provides reproduction services to patrons who are not affiliated with Elizabethtown College. Reproductions are delivered electronically by email or through an online electronic records delivery platform. When Elizabethtown College is the rights holder, the Archives reserves the right to limit delivery of reproductions for commercial purposes.

Reproductions of previously digitized materials: \$10.00 per scan

New reproductions created in-house: \$20.00 per scan

## **Reproduction Fee Discounts**

Elizabethtown College alumni, Church of the Brethren congregations and districts, and students from other institutions may receive their first 10 digital scans at no charge. Additional reproductions are offered at the following discounted rates.

Reproductions of previously digitized materials: \$2.50 per scan

New reproductions created in-house: \$5.00 per scan

## **Photocopies**

Elizabethtown College students, faculty, and staff may make their own photocopies of collection materials at the discretion of the Archivist. External requests for photocopies are provided at the following rates.

1-100 pages: \$10.00 plus postage

Additional pages in excess of 100: 50¢ per page
