## **How to Obtain a Tax Return Transcript:**

To obtain a 2019 IRS **Tax Return Transcript**, go to <a href="www.irs.gov/transcript">www.irs.gov/transcript</a>. Make sure to request the "IRS Tax Return Transcript" and **not** the "IRS Tax Account Transcript". Use the Social Security Number (or the IRS individual taxpayer number) and the date of birth of the first person listed on the 2019 IRS Income Tax Return, and the address on file with the IRS (normally this will be the address used on the 2019 IRS income tax return). If the student and spouse filed separate 2019 IRS Income Tax Returns, 2019 IRS Tax Return Transcripts must be provided for both.

#### How to Obtain a Verification of Nonfiling confirmation:

Go to <a href="http://www.etown.edu/offices/financial-aid/forms/">http://www.etown.edu/offices/financial-aid/forms/</a> and download a copy of IRS form 4506-T. Complete sections 1-5 and check box 7. A separate form must be completed for each non-tax filer. Mail or fax the form to the applicable address/number listed on the form.
