# **Instructions for IRS Data Retrieval or Tax Return Transcript**

If selected for verification, federal regulations require transferring your income tax information by using the IRS Data Retrieval Tool available on the FAFSA website at <u>https://fafsa.ed.gov/</u> or by submitting Tax Return Transcripts to Elizabethtown College.

If any of the following statements are applicable, you are <u>NOT ELIGIBLE</u> to use the IRS Data Retrieval Tool; therefore, you must submit a Tax Return Transcript to Elizabethtown College.

- My tax filing status is Married Filing Separately
- I filed an Amended Tax Return
- I filed a Puerto Rican or foreign tax return

### **IRS Data Retrieval Process**

The IRS Data Retrieval Tool is not available until two weeks after submitting your tax return electronically or up to eight weeks after submitting a paper tax return to the IRS.

#### 1. Go to https://fafsa.ed.gov/

- 2. Log in to the student's FAFSA application
- 3. Select "Make FAFSA Corrections" and navigate to the parent Financial Information tab
- 4. Answer the questions to determine if you are eligible to use the IRS Data Retrieval Tool to transfer 2015 IRS tax information into the student's FAFSA.
- 5. If eligible, the parent will be asked to enter their FSA ID
- Follow the online instructions to complete the IRS Data Retrieval process: Check box to Transfer My Tax Information into the FAFSA and then click Transfer Now.
- 7. Repeat process for Student Financial Information if the student filed a tax return for 2015.
- 8. Submit your correction by going to the Sign and Submit tab. Agree, sign, and enter FSA IDs for student and parent of Dependent students, if applicable.

## How to Request a Tax Return Transcript Online



- 2. Click "Get Transcript by Mail."
- 3. Read and agree to the IRS terms.
- 4. Follow prompts.

5. After successfully validating your information, you may expect to receive the IRS Tax Return Transcript within 5-10 days from the time the online request was made.

### How to Request a Tax Return Transcript by Phone

- Available from the IRS by calling 1-800-908-9946
- Tax filers must follow prompts to enter their Social Security number and the numbers in their street address. Generally this will be numbers of the street address that was listed on the latest tax return filed. However, if an address change has been completed through the U.S. Postal Service, the IRS may have the updated address on file.
- Select Option 2 for Tax Return Transcript request and enter the year you are requesting.
- If successfully validated, you can expect to receive the IRS Tax Return Transcript at the address that was used in the telephone request, within 5-10 days from the time the IRS receives the request.
